TEMPORARY TATTOO TERMS & CONDITIONS**

Preference L. Evans D.B.A. Art by Preference is currently providing temporary tattoo service for individuals 10 years of age and older. Additional paperwork must be completed for individuals under the age of 18.

Art by Preference WILL NOT apply a tattoo that serves as a form of punishment, consequence, or embarrassment to any minor child.

Before services are rendered, you must provide a valid photo ID that shows your date of birth. In order to receive temporary tattoo services from Art by Preference, you must take your time and read, then initial the indemnity form provided and sign it.

Only the person being tattooed may be present unless it is a minor being accompanied by an adult. Arriving on time is necessary, there is one reschedule included with your non-refundable deposit. Please arrive 5-10 minutes early when possible. Late arrivals may have to be rescheduled or canceled.

Tattoos will only be provided to healthy appearing, unbroken, non-irritated, undamaged skin. Tattoos will not be applied to any areas that are prone to moisture, sweating, or considered intimate. Tattoo pen ink will not be applied to the face, neck, or upper chest per product recommendations or on individuals under 10 years of age (if services are provided for this age group). Jagua gel and henna will not be placed near the eyes or to people under 8 years of age (if services are provided for this age group).

The product(s) used for the tattoos provided are documented as PPD Free and non-toxic, but on rare occasions, allergic reactions may occur. It is your responsibility to make sure that you do not have sensitive skin or other health conditions that may be affected by the application of a temporary tattoo.

Art by Preference can only make guarantees for her work, not the actual product being used or any bodily reactions that may result from the products being used.
